# **Schedule to Conditions of Entry**

Promotion Period	04 April 2025 – 03 April 2026 Every Friday 5:00pm – 7:00pm
Eligible entrants	Australian and New Zealand residents or tourists who are aged 18 years or older.  Directors, management and employees of the Promoter and their immediate family are not permitted to enter.  Patrons who are barred from Birallee Tavern are not permitted to enter this promotion.
Purchase of Product	For each \$5 an Eligible Entrant spends on food and beverage at Birallee Tavern between 5:00pm and 7:00pm each Friday during the Promotion Period, they will receive one ticket containing 4 numbers for entry into this Promotion.
The Prize	Jackpot prize. Starts at \$2000. (\$1000 cash, \$1000 venue credit). Jackpots by \$250 each week (half cash, half venue credit). Jackpots to a max of \$5000 total (half cash half venue credit)  First number drawn gets a pick at the board and a \$100 venue credit.  Second number gets \$50 venue credit.  Third number get \$25 venue credit.  Venue credit is awarded a single The Pass app credit for the prize amount. The Pass credit will be valid for two years from the date of it being awarded.
Total prize value	Up to \$5000 for jackpot plus \$175 in credit each week until the joker is chosen. Maximum prizes total value is \$14275.
