### COMPETITION TERMS AND CONDITIONS

#### Schedule to Conditions of Entry

<b>Eligible States/ Territories/ Countries</b>	All Australian states and Territories
<b>Promotion Period</b>	Every Friday 5:00pm – 7:00pm between 19 <sup>th</sup> March 2026 – 20 <sup>th</sup> March 2027
<b>Eligible entrants</b>	Australian and New Zealand residents or tourists who are aged 18 years or older. Directors, management and employees of the Promoter and their immediate family are not permitted to enter. Persons who are excluded from Birallee Tavern are not permitted to partake in this promotion.
<b>Purchase of Product</b>	1 ticket with 4 numbers for every food and beverage item purchased at Birallee Tavern between 5:00pm and 7:00pm each Friday during the Promotion Period.
<b>The Prize</b>	The Prize starts at \$1000 and increases by \$1000 each week the Joker is not selected. Up to a maximum of \$40,000. Each week 1 x \$25 venue voucher, 1 x \$50 venue voucher and 1 x \$100 venue voucher will also be offered as consolation prizes. Venue vouchers are in the form of The Pass credit. Each Friday at 7:00pm during the Promotion Period 4 random numbers will be selected. The first random number selected wins the \$25 venue voucher. The second random number selected wins the \$50 venue voucher. The third random number selected wins the \$100 venue voucher. The fourth and final random number selected is permitted to choose one (1) card from the game board. If the card selected is the Joker, the jackpot amount as it was prior to the draw that night will be awarded to the entrant.
<b>Total prize value</b>	Up to \$40,000.00 for jackpot, \$175 per week in venue vouchers.

The holder of the fourth ticket drawn in the Main Draw will have the opportunity to select one card from the Game Board. If the card selected is the Joker, the jackpot Prize will be awarded to that person. The winner of the Prize will be determined by a random draw from the entries received during the Promotion Period.
<b>Notification of winners</b>	The drawn winner of each prize may nominate one eligible person to collect the prize on their behalf should the drawn winner not be able to claim their prize in person. The

Jackpot winner will be awarded the jackpot prize at the time of the Joker being drawn.
